a. Indian Queens Recreation Ground

There is also a problem with water collecting in the corner of the car park, at the bottom of the slope to the toilets following heavy rain, all levels are draining to this point, I have asked the handyman to have a look, as a soakaway maybe needed. Water is collecting in the first cubicle of the unisex toilet, this has been reported to the builder who is going back to sort out.
